NOMINATION INFORMATION

METHOD OF NOMINATION

Nominated for election to the Board of Directors of the Association must be made in writing signed by five (5) members of the Association in good standing on the form approved and provided by the Board of nominations. A member in good standing is one who owns property in the Great Northwest, is current in payment of financials obligation to the Association, and not otherwise disqualified from voting at the annual meeting of Members of the Association. Nomination must include the written undertaking of the Nominee to serve if elected.

QUALIFICATION FOR NOMINATION

To be nominated and run for election to the Board, an individual must be (1) the owner of property in the Great Northwest; (2) resident in the Great Northwest; (3) current in payment of financial obligation to the Association; and (4) not otherwise disqualified from voting at the Annual Meeting of Members of the Association.

DEADLINE FOR NOMINATIONS

Nomination for the **2008** election to the Board of Directors will be accepted until **12 noon on February 15, 2008**, by the Election Officer designated by the Board, at the Association's main office, 8809 Timberwilde Drive, San Antonio, Texas 78250-4331. Nominations submitted after that time will not be accepted.

BIOGRAPHICAL INFORMATION

Nominees are invited to submit brief biographical information not exceeding 250 words in length to be distributed with the Notice of Election and of the Annual Meeting of Members. Submission of more than 250 words will be edited. This information must be received by the Association office staff at the Association's main office in the lodge of the Great Northwest, 8809 Timberwilde Drive, San Antonio, Texas 78250-4331 by **12 Noon on Friday, February 15, 2007**. Information submitted after that time will not be accepted nor distributed.
