Each Board meeting takes a couple of hours as the Board considers items of business on the agenda. While Board Briefs list decisions made by the Board, Members are encouraged to attend meetings to hear the Board as it discusses and debates matters upon which decisions must be made.

Actions taken by the Board:

January 19, Regular Meeting The Board:

- Replace the fence and gate by AAA
 Fencing for \$26,790.00, including one stone column to balance the existing column of the maintenance entrance
- Consensus to donate or give away the unused, upright piano to a good cause.

February 2, Executive Meeting The Board:

- Thirteen files, unresolved through the letter and notice process, were sent to small claims court, and one required more information before making a decision.
- Replace the Silver Creek pool coolcrete decking surface with the H3O bid for \$42,109.

Major Repair & Replacement (MR&R) Projects = Value to GNW Residents & Homes

The mission of GNW is to improve the quality of life of residents and preserve and increase the value of property for owners of property within the community. Toward that end whenever Major Repair and Replacement monies

will be spent our review

process includes an evaluation of current options, along with their costs, in order to optimize use and relevancy of facilities, vehicles, equipment, etc., to today's residents. These projects also give GNW homeowners a competitive edge when it comes to property values and sales.

SILVER CREEK POOL COOLCRETE RE-PLACEMENT

\$42,109 was approved by the Board for replacement of the coolcrete decking surface scheduled for replacement this year. After review of three bids H3O was the winning contractor with what happened to be the lowest bid. The Board wants to hear from staff that the bids were based on the same detailed job. They typically want a recommendation as to companies and our experience with them, or their references. The Board is not required to take the lowest bid.

LODGE PLUMBING REPLACEMENT

From time to time someone will ask why we have to put money into reserve savings, and this is the an example of why. The sewer line that runs from the back of the Lodge to the city sewer line under Timberwilde Drive in front of the Lodge. That's approximately 100 feet. We have experienced emergency drainage issues in recent weeks that with inspections and camera footage shows grade issues and three breaks in the lines probably due to building settlement and tree root growth. The Board selected a contractor's bid for \$16,405 for emergency replacement of these 4" underbuilding and under the front yard sewer drain pipes. The job includes hand digging a 3'x3' 35' tunnel under the Lodge from front clean out to the women's restroom. It also includes removal of all piping, engineering report, city permits and replacement of all the lines, dirt, and sod. The lowest price was \$15,426 and the highest was 46,006.

MAINTENANCE GATE & SOCCER FIELD FENCING REPLACEMENT

\$27,690 was the bid selected from AAA Fence Pros to replace the rusted and increasingly less functional maintenance gate and the fencing. AAA will replace the gate with a 4' x 21' wide commercial slide gate made to match the existing iron fence. The chain link fence between the large and lower soccer fields and the parking lot and Timber Path will be replaced with taller 6' iron fencing, which will prevent balls from posing hazards to drivers as well as players.

The Board of Directors, Community Manager and staff all use the best tools to make decisions in maintaining and replacing elements of community amenities. Tools such as a professionally prepared and calculated major repair and replacement schedule and the management best practice of obtaining

competitive bidding based on the same job details. Well maintained amenities are not only a pleasure to look at and

Ropal holds a degree in Business Administration Accounting from the University of Texas, San Antonio.He's married and has two daughters currently in college.



Applications for a ballot by mail must be submitted to the Bexar County Elections Department no earlier than 2 months before Election Day and no later than 11 days before.



You've been working for the Great Northwest for 24 years, but what did you do before?

I was a police officer for Leon Valley, Balcones Heights, and Bexar County

What do you do at the Great Northwest?

I make sure everything is secure, and everything stays in order on premises.

What is the most challenging part of your job?

Talking to people who are so upset that nothing I say will please them.

How do you handle that?

I talk to them in a calm voice and advise them that as best I can. For example, if their house has been burglarized, I will tell them what I do. I have locks in my house, because I'm in the business of security and police work. You want to make sure your home is secure. I believe in having pad locks on electrical boxes, so when the lights go out, CPS is knocking them out, not me or anyone else. That's a secure home. Locks on everything. If there's a place for it, there's a lock on it.

I have to ask... Do you put a lock on your refrigerator?

No, I don't need to. I just buy food that my brother doesn't like.

What do you do when you're not working?

I like metal detecting. You have to do a history of the area before you bring in your metal detector. I searched Stinson field and found a bag of coins from before 1964. I've found rings, a 1923 standing liberty. I've been doing it since 1979.

The Gardening Spot Busy Spring Gardening

March is a busy month in the garden—so much to do!

For lawns, it's time to fertilize. Go with organic fertilizer if you want to prevent polluting run-off water. Synthetic fertilizers are a major source of water pollution. Also time to top dress your lawn with compost as well as your your flower beds and vegetable garden. For best results aerate the lawn after top dressing. Watch out for your irrigation system lines. Top dressing has many benefits as well as adding nutrients.

Plant your favorite vegetables. Nothing is as good as

fresh picked chard, cucumber, tomatoes, spinach and summer squash. For herbs select from basil, oregano, sage, thyme and my favorite perennial, Rosemary. There are many varieties of Rosemary with different forms. Choose upright or trailing to suit your growing area.



Great time to plant trees; get them established before the major heat hits us.

Bulbs are always a favorite and seem to be popular in our neighborhood. Try Elephant Ears, Cannas, Day Lilies and Caladium. I always add some bone meal when planting bulbs.

If you haven't cut back your Firebush and Esperanza (Texas Yellow Bells) get it done now to prevent long scraggly looking shrubs. You can plant new shrubs now, too. For something a little different, try the orange Esperanza Tecoma 'Orange Jubilee'.

If you like annuals plant Coleus, Marigolds, Pentas, and Zinnias. Check plant labels to make sure you are planting in the correct light exposure.

Keep your garden clean by raking up leaves and debris that can harbor insects and disease. Add to your compost pile or dispose in the green organic recycling toters.

HOME REPAIRS THAT SHOULD NEVER BE PUT OFF Mark Zoller

Oh, the thought of tackling home repairs. Some projects can be annoying, costly, and time consuming. So often we put them off, justifying to ourselves that they

Light switch doesn't work? Whatever—you never go in that room anyway. Squeaky floors? You're already used

to them! But, there are some home improvement projects that simply can't wait. You may risk much bigger problems that can cost you time and money later. Here are some home repairs that should never be put off.

Director

A LEAKING ROOF: If you see water stains on your ceiling or down your walls, it is best to handle the problem right away. Not repairing a roof leak as soon as you notice it can lead to mold, damage to the structure of your home, water damage, and even fire if water comes in contact with electrical wiring.

CRACKS IN THE FOUNDATION: Your home's foundation may develop small cracks over time, and it's best to address them to prevent spreading. Otherwise you might have major problems with your foundation, which can be quite costly. Large cracks that go un-addressed can lead to everything from leaking water pipes to parts of the concrete collapsing.

GAS LEAKS: Since natural gas and propane are heavier than air, they "pool" in the low points of your home. The second you smell gas (a telltale rotten egg—like smell), call C.P.S. and vacate the premises until the technician arrives.

PLUMBING LEAKS: Leaking water can lead to mold, structural problems, and health issues. Homeowners should check under sinks at least once a year to ensure no water is leaking into the cabinets. If you see any leaks, call a plumber right away.

MOLD: When you see mold in your home, deal with it as soon as possible. The reason the mold formed in the first place needs to be determined and the problem fixed. While not all molds are life-threatening, all of them—even your shower mold can potentially make you sick.

OVERTAXED OR POOR ELECTRICAL SYSTEMS: More than 40,000 electrical fires occur each year in the United States. And most of them could have been easily avoided. Some warning signs of faulty electrical work include circuit breakers blowing unexpectedly, lights flickering, and outlets and/or switches being warm or hot to the touch. Not calling an electrician can result in your home catching fire.

CLOGGED GUTTERS: Clogged gutters are easy to ignore, but they can cause substantial damage to your home if you don't make it your business to keep them clean. The role of gutters and drainpipes is to draw rainfall away from the home. If they're stopped up, water begins to pool in vulnerable areas. You'll face a higher risk for wood rot around the facia and for foundation damage in low, sloped areas around the perimeter of your home.

CLOGGED DRYER VENTS: Removing the lint from your dryer vent prolongs the life of your dryer and prevents fire due to lint buildup. If you allow lint and other fabric to sit in a dryer vent, it will ultimately cause an airflow and exhaust backup that will turn into a fire hazard. So you have your work cut out for you. When you see warning signs, address them right away or risk bigger problems down the road.

Committee members heard 350 public comments during the public testimony portion of their meetings. After careful deliberation, the citizen Committees approved 173 projects and presented their recommendations on January 11, 2017 for City Council's consideration. City Council added seven projects and approved a total of 180 projects to be included in the May 6, 2017 Bond election.

I would like to thank all the District 6 residents who served on the 2017-2022 Bond Committees, especially Bill Mc-Donough & Myrl Britten from the Great Northwest Community. With their input & recommendations I am confident that San

Inoperable Vehicles Parked on Street

Any inoperable vehicle that is parked on the street is in violation of a City of San Antonio code. Residents need to call the San Antonio Police Department (SAPD) at their non-emergency telephone number at (210) 207-SAPD (7273) and request they have one of their police units tag the vehicle. Once a vehicle has been tagged the vehicle has 24 hours to be moved. After the 24 hour period SAPD can then have the vehicle removed by towing it the SAPD vehicle impound lot. Most of the time it will take the complainant to

make a follow-up call to have it removed. SAPD will require the address, type of vehicle, license number and the reason you believe it is inoperable or left abandoned.

GNW Membership Cards

Since February 1, 2017 anyone using GNW recreation facilities were to have a current 2017 sticker on the back of their cards. Beginning March 1, 2017 the security officers will be checking everyone's card. If you are not in possession of a card with a current 2017 sticker or you are not a guest of a card carrying member you will be asked to leave the premises. You will be required to have your card with you every time you are using a GNW facility. The GNW Lodge office is opened from 10:00 a.m. through 7:00 p.m.

Inoperable Vehicle Citations

Deed Restriction and Architectural Control Officer



Inoperable vehicles on your lot are in violation of Deed Restriction code 6.16: Storage of Automobiles, Boats, trailers and other vehicles (see the deed restriction on the right). It also reduces property values to have unsightly, inoperable vehicles on your lot. Just remember, your house is your home, but you are surrounded by neighbors who also call their houses home. Communities have to work together to keep property values up. If your neighbor has an unsightly fence, or a badly painted home, that may also reduce the property value of your home. Being a good neighbor means working with your neighbors to help keep the property values up for all the houses on your street.

You may have also received a ticket for an inoperable vehicle on

the street. This is a courtesy warning to you. Inoperable vehicles on the street are in violation of the City of San Antonio codes. When we give you a ticket for an inoperable vehicle on the street, we are really giving you a courtesy notice, notifying you that your vehicle may be ticketed by the City of San Antonio.

If your vehicle is tagged by the City of San Antonio, it must be moved within 24 hours. After that, the vehicle can be towed (with a cost of \$250 to retrieve it), and you could be fined up to \$350 by the city. That's a possible charge of \$600, just because your vehicle is inoperable or has an outdated tag. The Deed Restriction office would rather work with you to avoid that fee.

If you received a citation for an inoperable vehicle, here's what happens next if the issue is not corrected:

- 1. Courtesy Door Hanger (10 days to correct the violation)
- 2. 1st Delinquent Letter (15 days to correct the violation)
- 3. 2nd Delinquent Letter (30 days to correct the violation)
- 4. File goes to the Board of Directors for review.

Deed Restriction 6.16:

Storage of Automobiles, Boats, Trailers and Other Vehicles

No trucks, trailers, boats, automobile, camper or other vehicle shall be stored, parked, or kept on any lot, driveway, or in the street in front of the lot unless such vehicle is in day to day use off the premises and such parking is only temporary, from day to day and not to exceed forty-eight (48) hours in duration; provided, however, that nothing herein contained shall be construed to prohibit the storage of any unused vehicle in the parking facilities permitted on any lot covered hereby.

- a. No vehicle over eight (8) feet in height is permitted (e.g., cab of tractor-trailers or the trailer, monster trucks, delivery vans).
- b. Vehicles must have proper registration and safety stickers.
- c. No vehicles will be left on jacks (of any type) unattended.
- d. Minor maintenance may be done on vehicle(s) in the driveway of a home Provided the vehicle is operable and the area is cleaned in the same day.
- e. No inoperable vehicle is permitted on a lot unless it is screened from sight from the street or any other lot. Only fitted vehicles covers are permitted, no tarps or blankets will be used to cover a vehicle.
- f. No vehicle will be parked on any part of the property except the driveway.

state, but he always made sure to take a different route and give us adventures along the way.






