#### **GNW 2019 ELECTION & ANNUAL MEETING**

It's time to elect new Directors to the Board of Directors! As a refresher, the Board of Directors is the body that sets policies for use of common areas. ammentities, sets and approves the budget and conducts other Association business. This year, we have two candidates running, one for Director and one for Chairman. You can read more about these candidates on Page 2.

Here are a few key things that happen with the election proceess:

#### **Annual Meeting**

 ${
m The}$  Annual Meeting is an annual gathering of Great Northwest members. At the meeting is where the elected Board of Directors will take place and be announced. Besides elections, we also recognize residents who have demonstrated leadership and volunteership in the community. You actually still have time to nominate your neighbor by going to page 14.

#### Quorum

In order for the Annual Meeting to qualify as legal, we must have the participation of members. The minimum prescence of Members that we must have by person or proxy is 10%. That percentage is known as quorum.

If it happens where we do not meet quorum, the Annual Meeting is not considered legal, which means we would have to mail out a whole new proxy ballot, which costs around \$5,000 and go through the whole meeting again.

#### **Your Vote Counts!**

It is important to know that your vote is important and not just to reach quorum, but to voice your opinion in your community. Mailing will go out on April 1 and you will be able to vote when you receive your ballot in the mail or when you receive the email! If you would like an email ballot, please email your email to communicate@ greatnorthwest.org.

Come out and VOTE! On May 2<sup>nd</sup> at 7:30pm, please join us at the GNW Lodge as we will be hosting an election for the Board of Directors. The Board of Directors is the governing body responsible for approving community budgets, assessments and other Association business. They also set policy in place for the use of common areas and amenities. This year, Directors Brian Stives and Ida Rodkey are running for re-election for two open Director seats. You can view their bios on page 2 of this issue. Ballots will be mailed out to residents the first week of April. Included with the ballots, is a letter explaining the requirements residents must follow in order to have their ballots counted for the election.

#### PROXY

The ballot gives the opportunity to choose a proxy to vote for you at the Annual Meeting. If you are present at the Annual Meeting, you do not need to choose a proxy. Each member of the Board has volunteered to be a proxy for the election. Residents can also designate another individual to be your proxy, such as a neighbor. Complete the proxy ballot and return it to the Lodge, either in person or by return mail.

Property owners are entitled to vote in the election. There is one proxy ballot per residence. The most important aspect of the vote is that we must attain quorum, 10% of residents must vote for the election to be certified. Should we not attain quorum, we will have to hold another election until we do so. Residents can also vote electronically through the GNW website, <a href="www.greatnorthwest.org">www.greatnorthwest.org</a>. If you have not logged on yet, you will need to "Request a Login." It takes one business day to approve login requests. Call 210-681-2983 if you need assistance. The method you choose is up to you. In either case, PLEASE VOTE.

The Chairman of the Board and the Community Manager will provide reports on the status of the Association. 
#### Don't forget about your trash cans!

Trash cans are probably something you don't think about every day, but we do want you to start becoming aware of them. When trash cans are left out, this can lead to unwanted critters looking through the trash, on windy days, the trash cans can tip over or someone can run into them and leave a mess on the street or unwanted guests can go through them and search for your personel information.

For these reasons and more, we are starting to really crack down on trash cans being left out in your front yard.

In the CC&R, Article 6.5 states "Aritcle VI, Use Restrictions, Section 6. Every dwelling erected on any lot shall front of present a good frontage on the street on which said lot fronts. Dwellings on corners shall have a presentable frontage on all streets on which he particular corner lot abuts. No dwelling shall be erected on any lot having an area of less than 6,000 square feet, nor a frontage of less than 5,400 linear feet at the minimum set back on the street on which the lot fronts unless such lot is platted as a seperate lot in the aforesaid plot."



#### RECIPE CORNER: EASY SALISBURY STEAK

#### What you need:

1 lb Ground Beef

1/2 tsp Garlic Powder

1/2 tsp Minced Onion

3 tsp Ketchup

1 tsp Mustard

1 1/2 tsp Worcester Sauce

1/3 cup Bread Crumbs

1 packet of Brown Gravy Mix

#### **Instructions:**

- Combine all ingrediants, except brown gravy packet, in large bowl. Massage with your hands untill all the ingrediants are well mixed.
- 2. Pour 1 tsp of olive oil in a large skillet over medium heat.
- Mold patties into ball, place on skillet and slowly press down on ball until it is in a pattie thickness of your choice. Cook on both sides of patty until no longer pink in center.
- 4. Lower stove temperature to low.
- 5. Whisk and blend the gravy mix in a different skillet. Follow directions for

- gravy packet.
- 6. Allow pan to simmer until gravy thickens through.
- 7. Pour gravy over top of patties when gravy starts to thicken.





Most people in the Great Northwest know about the many greenbelts (flood control drainage areas) that run through

our community. The greenbelt runs from behind the community Lodge and runs all the way back until it runs into Tezel Road. This greenbelt was turned over to the GNW for the purpose of making it a Nature park. All other greenbelts throughout the GNW are controlled by the city.

There are many times the community residents ,whose properties back up to this area, will complain that there are people with their All Terrain Vehicles (ATV), Dirt Bikes and also about people walking their dogs. We need to understand that this is a greenbelt and the residents look at this for recreational purpose. There are also no policies against the GNW members from using the park for that purpose. The GNW's biggest problem we concern ourselves with is making sure homeless people don't set-up camps in it and that people don't use it as a dumping area. Now understand that just because you can have dirt bikes and ATV's in the area that does not mean you are to be considerate of the people that live in that area. There is a deed restriction that addresses someone that is being a NIUSANCE. So please be considerate when out in the greenbelt area.

When someone says something like "Creepy Crawly Things", the first thing most people will want to do is run, run, and run. Let's discuss those things I'm talking about. Those creepy crawlers I'm refering to are snakes, and this is the time of year for all kinds of snakes. This is largely due to the warm and wet weather the spring and summer months bring. As we discussed above, the GNW has many greenbelts. People and their children use this area for recreational purposes as we spoke about and of course the kids use it for taking shortcuts home. The parents of this community please speak to your children about these dangers that are in these greenbelts.

Now, let's talk about the snakes that you will run across in this area. The most common of snakes they will come upon will be the Water moccasin (Cottonmouth), Rattlesnakes, Copperhead and Coral snakes. The reason I bring these up first because they are the poisonous ones. The most common non-poisonous snakes in the area are King Snake, Rat Snake, Grass Snake and the Milk Snake. The King and Rat snake is probably the best to have around, since they feed on all types of rodents and other snakes (they are scary looking ones). 




